This year's Jimmy Awards ceremony will take place on **Monday**, **June 23**, **2025**, at the Minskoff Theatre on Broadway. Nominee and chaperone arrivals are scheduled for Friday, June 13th, at The Juilliard School dorms with Check-In beginning at 9:00am and Official Programming starting the following morning, Saturday, June 14th, at 8:30am. Jimmy Awards programming for participants will conclude on Tuesday, June 24th, at 1:00pm.

Due to a very condensed administrative window on the part of the Jimmy Awards as we approach June, we ask that you return all requested documentation by the appropriate deadlines. A list of all key dates and submission deadlines is provided on page 1 of this packet.

Please note that the Regional Awards Program must submit all requested materials; any materials submitted to us by individual Nominees, parents, or teachers will not be accepted. All submissions become the property of NHSMTA and will not be returned.

2. 2025 RULES & REGULATIONS

Only those programs that have been approved for participation by the NHSMTA are recognized as official Regional Awards Programs of the Jimmy Awards[®]. Click <u>here</u> for Participation Guidelines for more information.

Each Regional Awards Program (RAP) of the Jimmy Awards[®] must adhere to the following Rules & Regulations in order to participate in the 2025 Jimmy Awards[®]/ National High School Musical Theatre Awards[®] (NHSMTA[®]).

General

- The RAP is sponsored by a legitimate professional theatre/company that is a member in good standing of The Broadway League.
- The sponsoring legitimate professional theatre/company that is a member of The Broadway League has sponsored only one (1) RAP this year (unless an exception is approved by the NHSMTA Advisory Board).
- Every participating program must pay the participation fee in full, and the payment must be made by the Broadway League Member sponsoring organization.
- New Regional Awards Programs may send Nominees to New York in the first year of their program, if they so choose.
- In addition to the non-refundable participation fee, the RAP is also responsible for funding round-trip travel to New York City for its two Nominees (and Chaperone, if applicable). NHSMTA will arrange and pay for Nominees' expenses in New York City including housing, meals, and other necessary expenses for the duration of the program. Any expenses incurred outside of the scheduled program dates will be the responsibility of the RAP.
- The RAP must adhere to and comply with all <u>Press Guidelines</u> as outlined by the NHSMTA.
- The Jimmy Awards encourages diversity regionally whenever possible, including connecting to schools that may not have the budget to produce full-length musicals. We also encourage RAPs to select adjudicators, presenters, and guest performers from BIPOC and historically excluded communities. For additional resources, please see the section on page 6 titled "RECOMMENDATIONS TO INCREASE INCLUSION AMONGST REGIONAL PARTICIPANTS."

Nominee Selection Process

- The RAP is expected to adjudicate student performances through a full-scale Awards Program Model based on a Tony Awards® model (for reference please refer to similar programs such as Gene Kelly Awards, The Blumey Awards, or the Iowa High School Musical Theater Awards).
 - The RAP sends qualified judges to review high school musical theatre productions presented by individual schools during the 2024-25 school year. All aspects of shows, such as acting, choreography, design, etc. are judged on performance and production quality. To be considered for Jimmy Awards nomination, a student must perform a Qualifying Role in an Approved Musical in a full-length high school production that took place during the 2024-25 school year.



- All Regional Awards Programs must present awards at a full-scale public event in which nominees perform/participate in solo and group musical numbers for a live in-person audience of no fewer than 100 attendees (not including participants). While new Regional Awards Programs may choose to present a smaller culminating event for their first year, they are required to present a full-scale public event by the second full year of participation in the Jimmy Awards/National High School Musical Theatre Awards.
- At or before this event, RAPs must select two (2) nominees to participate in the Jimmy Awards. One student is announced as the Jimmy Awards Best Actress Nominee, and one student is announced as the Jimmy Awards Best Actor Nominee.
- Nominees for Best Performance by an Actor and Best Performance by an Actress are chosen based on the results of the adjudication of their performance of a Qualifying Role in an Approved Musical in a full-length high school production that took place during the 2024-25 school year.
- For the purpose of NHSMTA, qualifying roles will be defined per the list found here. Approved RAPs may appeal roles and musicals that are not on the current list for inclusion. School editions/versions of musicals are permitted; "junior" versions are not. Junior versions are usually referred to as: G2K (Getting to Know Series), Young @ Part, Middle School Editions (from 101 School Editions), Broadway Jr., Youth Editions, and Young Performers. Concert versions are not permitted.
- All nominees must meet any additional criteria and comply with all regulations as designated by the individual Regional Awards Program's policies for the 2024-25 season in order to be eligible as a Jimmy Awards Nominee.
- Regional Awards Programs must submit all required information and materials on behalf of their two participating Nominees by June 1st, regardless of culminating program event/ceremony date. Please refer to the Documentation & Materials section of the Rules & Regulations for further detail.
- Regional Awards Programs must ensure that their two participating Nominees have been informed of their nominations for the Jimmy Awards by June 1st.
- Regional Awards Programs must ensure that their two participating Nominees have been announced to the public no later than one (1) week prior to the start date of the NHSMTA week in NYC.

Nominee Requirements

Only those students who have been selected and designated as such by an official Regional Awards Program of the Jimmy Awards[®] are recognized as official Jimmy Award Nominees. Please see above for more information about the Nominee Selection Process.

- A Jimmy Awards Nominee must be a current high school student, grades 9 through 12.
- A Nominee's high school may participate in one (1) RAP only.
- A Nominee may participate in one (1) RAP only.
- A Nominee may represent one (1) high school and one (1) Qualifying Role only. The nominee will represent the high school that produced the Qualifying Show for which they were nominated.



- Nominees must be conflict free and available for all days during the NHSMTA week, tentatively scheduled for Friday, June 13th Tuesday, June 24th.
- Nominees are required to travel to New York City to participate in a rigorous 10-day program that will include individual coaching and group rehearsals for the Jimmy Awards ceremony.
- Upon arrival in NYC, Nominees will participate in a live Preliminary Adjudication to determine their award eligibility and Performance Group placement. The forty (40) Nominees who continue to be eligible for Finalist and Best Performance scholarships following the Preliminary Adjudication will participate in a second live Adjudication prior to the public Jimmy Awards ceremony.
- Nominees must understand and agree to all possible videotaping, televised opportunities, photos, press interviews, and print advertising. Waivers are provided in the Nominee Information Packet.
- Once a Nominee has won the Jimmy Award for Best Performance by an Actor or Best Performance by an Actress, they may not return in subsequent years to participate as a Nominee at the Jimmy Awards in New York City.
- Nominees must abide by any health and safety protocols implemented by either The Juilliard School or the NHSMTA.

Documentation & Materials

- Once accepted to participate in the NHSMTA Program, the RAP is required to submit the following
 necessary documentation in digital form. Please note that all material requirements are subject to
 change. Specific guidelines and upload instructions are provided in this RAP Participation
 Packet. All documentation is to be submitted to NHSMTA by the RAP, not by Nominees, their
 teachers, or their parents:
 - Participating High Schools List, which includes:
 - The name, street address, and phone number of each high school participating in the RAP
 - Show titles of each high school production adjudicated by the RAP
 - Dates of each production adjudicated by the RAP
 - The estimated number of students participating in each production adjudicated by the RAP
 - Each high school musical director's name, mailing address, email address, and phone number
 - The name of another primary contact at the high school, including phone number, email, and mailing address
 - RAP logo
 - RAP adjudication score sheet demonstrating process of determining Jimmy Awards nominees
 - Three digital images from RAP's 2025 ceremony

Recommendations to Increase Inclusion Amongst Regional Participants

- Create and publish a program Equity, Diversity, Inclusion, and Accessibility statement.
- Actively recruit a panel or group of program adjudicators, teaching artists, and coaches to include diversity of race, gender expression, age, disability status, and cultural background.
- Communicate and be transparent about gender inclusivity practices.
- Offer professional development sessions for teachers/show directors that include a focus on show selection and appropriate casting to ensure that productions reflect the racial makeup of the school/community.
- Offer anti-racism and/or anti-bias training for adjudicators, teaching artists, coaches, and program/venue staff.
- Consider participation opportunities for students who attend schools that do not currently produce musical productions or who do not meet Jimmy Awards/NHSMTA eligibility requirements.
- Offer scholarships, waivers, or reductions for school participation fees.
- Utilize virtual opportunities/programming to reach students and schools that may not be able to participate in-person.
- Include more expansive award categories in addition to performance.

3. QUALIFYING SHOWS & ROLES

The Jimmy Awards[®]/National High School Musical Theatre Awards[®] has reviewed the professional standards for identifying the definition of an Approved Musical and a Qualifying Role in an Approved Musical for the purposes of our program. These standards serve as a guide to create a minimum standard and criteria for what defines a Qualifying Role in the category of Best Performance by an Actor/Actress in an amateur production of an Approved Musical.

A. Definition of an Approved Musical

For the purposes of NHSMTA, an Approved Musical is one that:

- Held performances in a major New York City/Broadway theatre, professional regional, or touring theatre outside of New York City prior to being made available for licensing to the regional, amateur, or school theatre/circuit.
- Was originally conceived and produced for a core audience over eight years of age.
- Is officially available for a performance license by a high school from the licensing entity that manages such licenses on behalf of the rights holder for such musical.
- Is officially licensed from the licensing entity that manages such licenses on behalf of the rights holder for such musical.
- Is the standard or school edition/version; the following editions/versions are <u>not</u> eligible: 101 Collection (Middle School Editions), Broadway Junior, G2K (Getting to Know Series), Young Performers Edition, and Young@Part. Concert versions are not permitted.

B. Definition of a Qualifying Role

For the purposes of NHSMTA, a Qualifying Role in an Approved Musical is a role in which the character has a name, provides a vehicle for the actor or actress to demonstrate the ability to deliver the exceptional performance of a solo song, and the ability to interact with other leading and featured performers in scenes and/or songs. Unless identified as an "Ensemble Cast Musical," an Approved Musical may have not more than six (6) Qualifying Roles.

For Approved Musicals with both a book and libretto, a Qualifying Role must, at minimum, include:

- a. At least one (1) solo, featured song
- b. Appearances in more than one (1) scene with spoken dialogue with other leading or featured performers
- c. Appearances in both or all acts

For Approved Musicals with a libretto only, a Qualifying Role must, at minimum, include:

- a. At least one (1) solo, featured song
- b. At least one (1) song featuring solo lines in dialogue with other leading or featured performers in the same song
- c. Appearances in both or all acts



C. For the purposes of the NHSMTA program, students are adjudicated in the category corresponding to their gender identification, not the gender of the role that they played. Students identifying as non-binary or gender-fluid may choose to either select the category in which they wish to be adjudicated (regardless of the gender of the role) OR they may be adjudicated based on the gender of the role they played. All casting or script change requests for performances in the NHSMTA program must be approved beforehand. The regional awards program should be prepared to submit proof of approval from the show's licensing organization.

4. APPEAL PROCESS

A Regional Awards Program (RAP) may submit an Appeal for either a musical or role to be considered an Approved Musical or a Qualifying Role after such RAP has applied to and been notified of their acceptance to participate in the NHSMTA. Appeals must be submitted using the 2025 Appeal Form, found here or at the link below. Appeals must be made prior to April 1, 2025. Appeals made after April 1st cannot be assured approval for the 2025 NHSMTA. The Appeals Committee will consider all appeals and make a determination according to the review schedule outlined on the Appeal Form.

This process has been established to ensure all RAPs use the same method and have the same opportunity to submit appeals.

Updates to the list of Approved Musicals and Qualifying Roles

Each year, in consultation with the major licensing houses, NHSMTA updates the list of Qualifying Roles and Approved Musical titles made available for high school licensing. As of September 1st each year, no roles will be removed from the Qualifying Roles List for the upcoming program year. However, because appeals are made and approved throughout the year, the list of Qualifying Roles continues to be updated with additions. RAP representatives should consult this list periodically to ensure that you have the most current list, which will be fully updated for the year by May 1, 2025.

6. SOCIAL MEDIA GUIDELINES

As the Jimmy Awards social media presence evolves, the Broadway League Digital team has created the following guidelines for best practices for engaging with the Jimmys social feed. Similar to the program's press guidelines, Regional Award Programs should follow the guidelines below when interacting with the Jimmy Awards social channels and are encouraged to reach out with any questions.

SHARE SHARE!

Leading up to the Jimmy Awards, especially during RAPs season, we feature photos, videos, and reels from RAPs and various information on ticketing, past Jimmys performance content, etc. We do our best to tag sponsors and RAP accounts. If you are tagged in a post from @jimmyawards, please share the post on your account's IG stories!

TAG US IN POSTS!

Theatre people help theatre people! Make sure to tag @jimmyawards if you're posting Jimmys-related content on your IG account. If you post about the Jimmys on your stories, tag us, too! We would love to share content from our RAPs on our stories but cannot do so if our account is not tagged.

SAVE SAVE SAVE!

Make sure to like, comment, and—most importantly—save the post(s). Saves are gold in Instagram currency and help drive traffic to our page, which could also drive traffic to your pages!

AVOID!

Using apps such as Regram to share content from @jimmyawards or screen recording our videos to share on your account(s).

This is not the most efficient way to increase visibility for the Jimmy Awards nor for your programs and/or sponsors. Even worse, it can create a copyright issue. If you're having trouble finding an asset you'd like to post, please don't hesitate to reach out to us!

7. 2025 STUDENT REPORTER SEARCH

Each year, the Jimmy Awards invites select Student Reporters from participating Regional Awards Programs to cover Jimmy Awards events through social media. This provides a chance to expand connections into local schools' journalism, film, and other related departments. Student Reporters work directly with the Jimmy Awards Digital team which allows them to receive an insider look at the digital marketing strategy of Jimmy Awards coverage while gaining insight into the field as a whole.

Two (2) Student Reporters identified via a national search will be brought to NYC to cover the Jimmy Awards this year. Applicants may be submitted by their RAP only and must NOT be students who are eligible to compete as a nominee for The Jimmy Awards. There is a limit of two (2) student reporter applicant submissions per RAP. Submissions are due on Monday, April 14, 2025.

All applicant materials must be submitted by the RAP. You may use the Student Reporter Submission Form provided on pages 42 - 44 (*Reference Form C*) if it is useful in collecting this information from your applicant(s), however, you will input each answer into individual fields in the Google Form linked below.



- This page may be shared with prospective applicants explaining our rules and criteria. Feel free to distribute this to the teachers and schools in your RAP network. How you choose your student reporter applicant(s) is entirely up to your program.
- The form to submit your chosen student reporter applicant(s) can be found here. This page is for your use only; do not share it with schools or students. The form includes a link you may use to upload your applicant video(s). Jimmy Awards Student Reporter submissions are due no later than Monday, April 14. If you have any issues with the form or uploading the video(s), please contact Erin Coffey at ECoffey@Broadway.org.

Student Reporter candidates will be notified whether they will move on to the second round of consideration on or around May 5, 2025. Finalists will be notified of the outcome of their application on or around June 2, 2025. Notifications will be sent directly to the candidates at the email address provided. The RAP Manager will be copied on the notification email.

8. NOMINEE PERFORMANCE GROUPS & ADJUDICATION PROCESS

Following master class-style sessions with Jimmy Awards audition coaches, the Nominees will participate in a Preliminary Adjudication on Monday, June 16th. The preliminary judging panel will include casting directors, producers, and other industry professionals. At this adjudication, the Nominees will perform a 32-bar cut of a song from the role for which they were nominated in addition to a one-minute cut of a Solo Song of their choice. Nominees must provide two (2) copies of their own piano sheet music with their cuts clearly marked to be used both during Preliminary Coaching sessions and the Preliminary Adjudication. The results of this Preliminary Adjudication will determine the Nominees' Performance Group assignments and award eligibility.

Those Nominees assigned to The Character Group will continue to be in consideration for Finalist and Best Performance awards and scholarships. Those Nominees assigned to The Feature Group will no longer be in consideration for Finalist or Best Performance awards and scholarships, though they will continue to be eligible for all other awards and scholarships.

Forty (40) Nominees – twenty (20) Best Actress and twenty (20) Best Actor Nominees – will be assigned to The Character Group. All other Nominees will be assigned to The Feature Group. All Nominees in both groups will perform in both the Opening Number and Closing Number on the stage of the Minskoff Theatre.

Character Group nominees will perform a selection from the role for which they were nominated, in medley format, on the stage of the Minskoff. This group will not perform in the Feature Number.

Feature Group nominees will perform on the stage of the Minskoff in a themed group number. This group will not perform in a Character Medley.

The Sunday immediately before the ceremony, Nominees will showcase the Opening Number and the Feature Group Number for the Minskoff Judges, a panel of experts comprised of producers, casting directors, and industry professionals. Those Nominees in The Character Group will participate in a Final Adjudication during which they will perform their Character Medleys and will each sing one solo song up to three minutes in duration prepared during the week with Broadway coaches. Following this Adjudication, the Minskoff Judges will select eight (8) Finalists – four (4) Best Actress Nominees and four (4) Best Actor Nominees. All eight (8) Finalists will receive award scholarships.



Those eight (8) Finalists will be announced and recognized at the ceremony and will sing their selected solo songs on the Minskoff stage during the second act. From these eight (8) Finalists, the judges will choose the winners of the Jimmy Awards for Best Performance by an Actress and Best Performance by an Actor by ballot vote live during the second act of the ceremony.

Additional awarded scholarships this year will include Best Dancer, Rising Star, Outstanding Performance in an Ensemble (5), and Spirit of the Jimmys, for a total of sixteen (16) individual scholarships.

Below is an overview of which awards and scholarships are available to the Nominees in each Performance Group.

Recipients of the following awards and scholarships will be selected from The Character Group only:



9. SAMPLE DAILY SCHEDULE

The sample schedule is intended to be a tool in helping Nominees prepare themselves for the rigor and pacing of this 10-day intensive.

10. TICKET INFORMATION

There are three components to the evening of the ceremony: (1) The Pre-Show VIP Reception immediately prior to the ceremony that is by invitation only and part of some **sponsorship benefits**, (2) the Jimmy Awards ceremony at the Minskoff Theatre, and (3) the After-Party which is open to all involved and their guests, at Hard Rock Café in Times Square. **The NHSMTA strongly suggests that Regional Awards Programs consider the needs of nominees' families when allocating tickets.**

- Included in your venue's \$15,000 participation fee, each RAP receives four (4) orchestra seats to the ceremony and four (4) After-Party Passes. Pre-Show VIP Reception tickets are NOT included or available for purchase.
- DUE JUNE 2, 2025: RAP Ticket Confirmation Form

 As soon as you know what names you would like your RAP's four (4) ceremony tickets and four (4) After-Party Passes to be held under, please complete and submit the RAP Ticket Confirmation Form to secure your tickets. If you do not confirm your tickets, they will be released.
- Please note that in addition to the tickets confirmed with the Google Form above, each Chaperone will receive one Jimmy Awards ceremony ticket (separate from the venue's four ceremony tickets) and one After-Party Pass to be used by the Chaperone. Chaperone ceremony tickets and After-Party Passes are non-transferable.
- Each Nominee will receive one After-Party Pass to be used by the Nominee. **Nominee After-Party Passes are non-transferable.**

RAP ADVANCE SALE TICKETS

- Each Regional Awards Program has the option to request up to ten (10) tickets via our advance sale that is open exclusively to regional programs.
- Once confirmed, you will receive an email from Broadway Direct prompting you to submit credit card information. These tickets are priced at \$175.
- We cannot accommodate requests for these tickets to be near the RAP Ceremony Ticket locations.
- All Advance Sale ticket requests must be received by June 2, 2025.



- If there are unclaimed tickets in the Advance Sale allotment after the June 2nd deadline, RAPs may request additional tickets before any public sale begins. Tickets requested after the June 2nd deadline will be allocated on a first-come, first-served basis and will be priced at the premium rate of \$350.
- Tickets purchased via the Advance Sale will be available for pick up at the Minskoff Box Office window starting at 10:00am on Monday, June 23rd.
- Any remaining tickets in the theatre will go on sale to the public on Monday, June 9th.

14. INSPIRING TEACHER AWARD NOMINATIONS (Optional)

Jimmy Awards Nominees have the option to nominate one (1) theatre teacher or teacher who leads the theatre program at the high school that produced the Qualifying Show for which they were nominated to be considered for one of two Inspiring Teacher Awards that will be presented at next year's Jimmy Awards ceremony. The goals of the Inspiring Teacher Awards are: 1) to honor theatre educators for their commitment to excellence in high school musical theatre, 2) to raise the profile of teachers who present musicals at their schools, and 3) to honor theatre educators for their support of Jimmy Awards nominees.

Award Parameters:

- Recipients must be teachers of Jimmy Awards nominees in a full-time position at the high school that produced the Qualifying Show for which the student was nominated.
- Up to two (2) educators will be selected as the recipients of the award by a designated Taskforce comprised of members of the Broadway League's Audience Engagement Committee (members of the Taskforce may not be associated with a Regional Awards Program).
- The Inspiring Teacher Awards will be bestowed at the following year's ceremony.

To Nominate a Teacher:

All nomination information must be submitted by the RAP. You may use the Inspiring Teacher Award Nomination Form provided on pages 64 - 66 (*Reference Form K*) if it is useful in collecting this information from your nominees who wish to nominate a teacher, however you will input each answer into individual fields in the Google Form linked below.

Any nominee who wishes to nominate their teacher must make an approximately 60 second video describing or showing why their teacher deserves this award, provide additional information about their high school theatre program, and answer the following 6 questions in writing in complete sentences. Please note that the content of the video should be distinct from the short answer responses and may include contributions from other students, alumni, faculty, parents, and/or community members.

- Why does your teacher deserve special recognition?
- Describe three (3) specific skills you have learned from your teacher.
- How does your teacher inspire you?
- How does your teacher make everyone feel included and valued in the classroom or in a production?
- What is the most valuable lesson you have learned from your teacher?
- What advice has your teacher given you about the professional world/life after high school?

5. Chaperone Approval/Travel Companion Selection Form: <u>Due by March 14, 2025</u>

There are several options available to the NHSMTA RAPs managed directly by Broadway League Member organizations with respect to the chaperoning, travel, and supervision of the student Nominees. NHSMTA has designed a policy that first and foremost assures the safety of the students while also responding to the needs and capabilities of each RAP.

As of 2023, all RAP Chaperones must be employees of the Broadway League Member sponsoring organization. If a RAP is unable to send a Chaperone who is an employee of the Broadway League Member sponsoring organization, that RAP must utilize an NHSMTA Chaperone and pay the accompanying fee.

Fill out the form above to select one of the following options. Please note for Option 1, only one (1) chaperone per RAP is permitted for the duration of the Jimmy Awards week.

➤ Option 1 – RAP Chaperone: Roles and Responsibilities

A Chaperone's primary responsibility is the welfare of all Nominees during the NHSMTA week. Each Chaperone will be expected to collaborate throughout the week with a group of Chaperones to oversee a "pod" of Nominees, comprised of the two (2) Nominees from the Chaperone's RAP as well as Nominees from other Regional Awards Programs.

As of 2023, all RAP designated Chaperones must be approved in advance by the NHSTMA/Jimmy Awards. All Chaperones are required to:

- 1. Be at least 21 years of age by June 13, 2025.
- 2. Be employed currently by the Broadway League Member organization that sponsors the RAP they represent.
- 3. Pass a background check.
- 4. Complete any and all required training/education, including but not limited to Mandated Reporting of Abuse training.



- 5. Commit to chaperoning the entirety of Jimmys Week (June 13 June 24, 2025) without interruption, except in cases of illness or personal emergency.
- 6. Remain fully apprised of all medical needs of the Nominee(s) throughout Jimmys Week, including prescription medication, special dietary needs, and any ongoing care needed as related to a known health condition.
- 7. Conduct nightly bed checks and floor checks as directed and remain in the Chaperone's assigned housing after such checks.
- 8. Collaborate throughout the week with a group of Chaperones to oversee a "pod" of Nominees, comprised of the two (2) Nominees from the Chaperone's RAP as well as Nominees from other Regional Awards Programs.
- 9. Comply with all instructions and/or directives given by NHSMTA/Jimmy Awards staff, including NHSMTA Chaperones/Pod Leaders.

Chaperones are not responsible for costume coordination, artistic input, or program administration, nor is there access to rehearsal or coaching sessions unless expressly invited by the NHSMTA ceremony director.

If you select **Option 1: RAP Chaperone**, you will be prompted to complete the RAP Chaperone Approval Form.

All information must be submitted digitally through the linked Google Form above. Please note that you must complete this form in one sitting. Reference Form A (pages 33 - 37) is provided for your reference.

➤ Option 2 – NHSMTA Chaperone: Roles & Responsibilities

In the event the RAP is not able to or does not wish to send a RAP Chaperone, the RAP may elect to use an NHSMTA chaperone. **SHOULD YOUR RAP SELECT THIS OPTION, A CHAPERONE FEE OF \$1,000.00 WILL BE INCURRED. Payment will be due 30 days from completion of the form.** Click here to download a fillable invoice for the NHSMTA Chaperone Fee. You will be prompted to upload your completed invoice via the Google Form.

NHSMTA will:

- Provide pre-determined NHSMTA Chaperone engaged and vetted by NHSMTA who will be assigned to the RAP's Nominees for the duration of the program.
- The name and contact information of the NHSMTA Chaperone representative providing such services to the RAP student Nominees will be made available to the RAP and parents of each student Nominee and advance communication will be coordinated with all parties by NHSMTA.
- NHSMTA Chaperones must be at least 21 years of age by the program date in New York City (June 13 June 24, 2025).
- NHSMTA Chaperones are subject to a background check.

If opting to use a NHSMTA Chaperone, you will select one of the following two travel options:

❖ Option A – Travel Companion

In the event the RAP wants to oversee the Nominees' travel to/from The Juilliard School in New York City, but elects not to send a RAP Chaperone, the RAP may send a "travel companion" to travel with the students (RAP Travel Companion). This person can be one of the Nominees' parents, friend, teacher, or other RAP designate.



- The RAP Travel Companion will be responsible for accompanying the Nominees to The Juilliard School on the first day (June 13, 2025) to sign them in and transfer responsibility to the NHSMTA.
- The RAP Travel Companion will not stay at the Juilliard dorms. At the end of the program (June 24, 2025), they will sign the Nominees out from The Juilliard School to accompany them home to the RAP.
- RAP Travel Companions must be at least 21 years of age by the program date in New York City (June 13 June 24, 2025).

❖ Option B – Independent Student Travel

In the event your RAP determines that the students are capable of traveling without a RAP Travel Companion and the RAP does not wish to or is unable to send a RAP Chaperone, NHSMTA will provide a representative to meet the Nominees at the airport, bus, or train station and escort them to/from The Juilliard School at the beginning and end of the program. The earliest pick-up time that can be accommodated by NHSMTA Staff on arrival day is 8:00am Eastern.

- **10. Nominee Headshot**: Must be a high-resolution color jpg file (8" x 10" at 300 DPI). Headshots must be uploaded to the Acceptd Portal and labeled as "(Nominee Last Name) (Nominee First Name) Headshot".
- **11. Nominee Resume**: One (1) page. Please see *Reference Form F* on page 57 for required format. Resumes must be uploaded as a PDF document to the Acceptd Portal and labeled as "(Nominee Last Name) (Nominee First Name) Resume."



- **12. Nominee Essay**: One (1) page, double-spaced essay describing Nominee's experience participating in theatre or performance this year. Essays must be uploaded as a PDF document to the Acceptd Portal and labeled as "(Nominee Last Name) (Nominee First Name) Essay."
- **13. Nominee Bio**: No more than 200 words, written in complete sentences in third person format. Bios must be uploaded as a PDF document to the Acceptd Portal and labeled as "(Nominee Last Name) (Nominee First Name) Bio."
- **14. Three (3) Nominee Qualifying Role Production Images**: Three (3) images highlighting the Nominee in their nominated performance of a Qualifying Role in their high school musical. Photos must be uploaded to the Acceptd Portal and labeled as "(Nominee Last Name) (Nominee First Name) Image 1 (Photographer Credit);" "(Nominee Last Name) (Nominee First Name) Image 2 (Photographer Credit);" "(Nominee Last Name) (Nominee First Name) Image 3 (Photographer Credit)."
- 15. Nominee Topic Response Video: The Nominee's Topic Response Video is an opportunity for each Nominee to showcase their background, interests, and personality by responding to several questions in an interview style video. Please see the link below for the list of interview questions. The Nominee should answer all the questions, in complete sentences, and include the question in their answers (ex. The answer to the question "What is your name?" would be "My name is Erin Coffey."). Please note: Selections from Topic Response Videos may be used in the ceremony presentation or other Jimmy Awards channels. Please be sure interviewer does not speak over or overlap with Nominee responses.

Topic Response Video Filming Instructions and Tips:

- Set up cameras and lighting as demonstrated in the first video linked below. *Note that the video uses professional video camera and lighting equipment, but the same set-up will work with a good/new smartphone and a ring or clip light.*
- Recruit a family member or friend to ask the questions. The "interviewer" should be positioned just off camera, at lens level.
- The Nominee should make eye contact with the interviewer and deliver answers directly to them. It is best to avoid looking directly at the camera. Be sure to include a pause before and after the answers to ensure the interviewer does not overlap with the Nominee's answers.
- Frame the shot so it is about chest up with a little room above the Nominee's head. When in doubt, err on the side of a wider frame.
- External microphones are great if available (though not necessary), but they should not be held in the Nominee's hand. Any microphone used should be either attached to the Nominee's body (if a lavalier) or placed just out of frame.
- Record a test and play it back to make sure everything looks great.

16. Music Submission Form: The music selection information below will be needed to complete your Acceptd applications. You may use the Music Submission Form provided on pages 58 – 59 (*Reference Form G*) if it is useful in collecting this information from your Nominees, however you will input each answer into individual fields in the Acceptd portal. A flowchart detailing how music selections are utilized throughout Jimmys Week is on page 28.

The Nominee will list a total of six (6) songs that fall under two (2) categories: two (2) Song Selections from Nominated Qualifying Role and four (4) Solo Song Selections. The Nominee must be off-book and prepared to sing all six (6) selections upon arrival in NYC.

- SONG SELECTIONS FROM NOMINATED QUALIFYING ROLE The two (2) most prominent songs from the Nominee's performance of the Qualifying Role for which they were nominated to potentially be performed if the Nominee is placed in the Character Group following the Preliminary Adjudication. If you do not know the key in which the song(s) was performed, sheet music will be provided to the Nominee in the original key. Please note:
 - a. If the role only has one (1) solo selection in the show, only list one (1) song.
 - b. Do not list a song from the musical that is not performed by the Nominee's Qualifying Role.
 - c. There is no guarantee either of these songs will be chosen to be performed if the Nominee is in the Character Group. Final song selection is at the discretion of the Music Director/Arranger.
- ➤ SOLO SONG SELECTIONS The Nominee's two (2) up-tempo and two (2) ballad musical theatre solo selections to prepare for individual work with the vocal coaches during the Jimmy Awards week should the Nominee be assigned to The Character Group following the Preliminary Adjudication. One (1) of these four (4) songs will be chosen in collaboration with the Nominee's coach to be performed for the Minskoff Judges at the Final Adjudication on Sunday, June 22nd. If selected as one of the eight (8) Finalists, the Nominee will perform said song on the stage of the Minskoff Theatre in the second act of the ceremony.

Please ensure that the Nominee knows and is prepared to sing each of the four (4) Solo Song Selections submitted via the Music Submission Form. While the Nominee and their coach will ultimately choose one of these four songs during Jimmys Week, the Nominee must be familiar enough with the material upon arrival to sing each song for their coach in order to make the best determination for the Nominee.

Please provide the first choice up-tempo and ballad selections, in addition to a second choice/alternative as a back-up for each. Solo song selections must NOT be from the Nominee's nominated qualifying musical. If you do not know the preferred key, sheet music will be provided in the original key.

The Jimmy Awards has compiled a Library of Approved Solo Song Selections that have already been vetted and edited by our music team for your reference and convenience. Should a Nominee wish to select a solo song that is NOT found in the below Library of Approved Solo Song Selections, you may still submit the song as a request for approval. Please see below for instructions.

Solo Song Requests

If submitting a song NOT in the provided library, please indicate so by checking the appropriate box underneath the song title field on the Music Submission Form. Please note:

- o All solo songs requested must be from a show on the Qualifying Shows List.
- o All solo songs requested must **ALSO** be from a Broadway production. Please note that there are many shows on the Qualifying Shows List that are *not* Broadway productions.
- O DO NOT submit solo song requests from shows that are not on the Qualifying Shows List, songs from Off-Broadway shows (even if the show is on the Qualifying Shows List and/or has been performed by a Finalist in the past), or songs from shows that opened on Broadway this season and/or do not have published sheet music.

Please do not assume that your solo song request is approved until you receive a definitive answer via music@jimmyawards.com. If a request is approved, an up to three-minute cut of the music will be uploaded to the Library and provided to the Nominee for use during the Jimmy Awards program if the Nominee is assigned to the Character Group following the Preliminary Adjudication. If the requested solo song will be used for the Preliminary Adjudication, the Nominee will still be responsible for bringing two (2) copies of their own sheet music with a clearly marked one-minute cut. If you are submitting a solo song request but do not yet have the rest of your materials ready for submission on Acceptd, please email a PDF copy of the completed Music Submission Form with the solo song request to music@jimmyawards.com so that we can expedite the request. If the solo song request is NOT approved for any reason, the Nominee will submit another song choice in its place.


Whether Nominees select songs from the existing library or submit solo song requests, no more than four (4) Nominees may select the same solo song as their first choice. If more than four Nominees have selected the same solo song as their first choice for either their up-tempo or ballad, there will be a lottery to determine which four Nominees will work on that specific song with coaches during Jimmy Awards Week. Final music determinations will be made by June 10, 2025.





17. Nominee Wardrobe Information Form: Each Nominee is required to bring three (3) formal outfits to NYC as outlined below. While it is not required, Nominees may choose to bring the costume they wore in their performance of their Nominated Role. The Jimmy Awards may provide some or all of a Nominee's costume pieces for the ceremony.

Each Nominee must submit measurements and **videos of all wardrobe pieces they plan to bring to NYC** (see description below). Please see the Nominee Wardrobe Information Form provided on pages 60 – 61 (*Reference Form H*) for required responses. You may use these pages if it is useful in collecting this information from your Nominees, however, you will input each answer into individual fields in the Acceptd portal, rather than scanning and uploading the forms.

Nominees must be prepared to turn in the following wardrobe elements to the Jimmy Awards Costume Coordinator immediately following their Preliminary Audition on Monday, June 16th. Nominees will not be permitted to access these items throughout the week.

Example pictures of the garment options detailed below are on page 61. A flow chart for how these items may be used is on page 31. When packing their formal outfits, please remind Nominees that they must be able to move easily while wearing them. They may be dancing, bending over, and squatting in these outfits, and they will need to be comfortable, as well as appropriately covered and supported. For lighting purposes, please also avoid shiny/shimmery fabrics.

REQUIRED COSTUME 1 – Solo Outfit: Black formal outfit(s) to be worn for Preliminary Adjudication and possibly on stage for the Opening Number, Closing Number, Feature Number, or Finalist Solo during the ceremony. Garment parameters and options include:

- Fabrics should be solid colors (no patterns) and matte or dull finish (not shiny or shimmery)
- Black suit, black dress pants, or black dress skirt with:
 - o 2 contrasting, collared, button-down dress shirts OR blouses one white and one vibrantly colored (solid colors only, please)
 - o (Optional) Tie, standard tie or bow tie solid black
 - o (Optional) Vest, suspenders, or suit jacket solid black
- Knee-length black dress
 - o No mini-skirts or mid-thigh length dresses
 - O Wrap style tops must be secured or sewn closed
 - o (Optional) Black spanks or trunks
- Dressy black jumpsuit
- Shoes & Accessories
 - o Black dress shoes of choice (character shoes, heels, dress shoes, etc.)
 - o Black socks, if applicable to shoe choice
 - (Optional) 2 3 inch black character shoes, link to options **HERE**
 - o (Optional) Skin tone tights link to options **HERE**

REQUIRED COSTUME 2 – Warm Color Outfit: Solid red, orange, yellow, or pink formal outfit(s) to possibly be worn on stage for the Opening Number, Closing Number, Feature Number, or Finalist Solo during the ceremony. Garment parameters and options include:

- Fabrics should be solid colors (no patterns) and matte or dull finish (not shiny or shimmery)
- Black suit, dress pants, or dress skirt with a red, orange, yellow, or pink collared, button-down dress shirt OR blouse



- Knee-length dress in solid red, orange, yellow, or pink
 - o No mini-skirts or mid-thigh length dresses
 - Wrap style tops must be secured or sewn closed
 - o (Optional) Black spanks or trunks
- Dressy jumpsuit in solid red, orange, yellow, or pink
- Shoes & Accessories
 - o Red, orange, yellow, or pink accessory such as a suit jacket, belt, vest, tie, suspenders, etc.
 - \circ 2 3 inch skin tone character shoes, link to options **HERE** and **HERE**

REQUIRED COSTUME 3 – Cool Color Outfit: Solid purple, blue, or green formal outfit(s) to possibly be worn on stage for the Opening Number, Closing Number, Feature Number, or Finalist Solo during the ceremony. Garment parameters and options include:

- Fabrics should be solid colors (no patterns) and matte or dull finish (not shiny or shimmery)
- Black suit, dress pants, or dress skirt with a purple, blue, or green collared, button-down dress shirt OR blouse
- Knee-length dress in solid purple, blue, or green
 - o No mini-skirts or mid-thigh length dresses
 - o Wrap style tops must be secured or sewn closed
 - o (Optional) Black spanks or trunks
- Dressy jumpsuit in solid purple, blue, or green
- Shoes & Accessories
 - o Purple, blue, or green accessory such as a suit jacket, belt, vest, tie, suspenders, etc.
 - \circ 2 3 inch skin tone character shoes, link to options **HERE** and **HERE**

360° Videos must be uploaded to the Acceptd Portal and labeled as "(Nominee Last Name) (Nominee First Name) Solo Outfit Video," "(Nominee Last Name) (Nominee First Name) Warm Color Outfit Video," "(Nominee Last Name) (Nominee First Name) Cool Color Outfit Video."


OPTIONAL COSTUME 4 – Nominated Role Costume: Please read carefully. <u>This costume element is not required</u>. If the Nominee is assigned to The Character Group, they will be costumed according to the Qualifying Role for which they were nominated. If they have easy, unrestricted access (i.e. they can wear it without any additional purchases or rental fees and with permission from the owner and/or designer) to the costume or elements of the costume they wore in their Qualifying Show production and those elements are easily packed within their other luggage, they should bring them! Shipping of any kind is not permitted and will be automatically returned to sender. If they do not have easy, unrestricted access to their costume or it cannot fit within their other luggage, they should not bring their Nominated Role Costume. If assigned to The Character Group, they will be provided costume pieces selected by the Jimmy Awards Costume Coordinator.

The Costume Coordinator, Ceremony Director, and Ceremony Choreographer make all costume determinations. Regardless of whether the Nominee brings costume elements to NYC and regardless of which costume elements they bring, the Costume Coordinator may provide them with costume pieces to supplement and/or replace items they bring. Whether they bring this costume element with them to NYC will have no bearing on their Nominee Performance Group assignment.

If they decide to bring this costume, a 360° Video must be uploaded to the Acceptd Portal and labeled as "(Nominee Last Name) (Nominee First Name) Nominated Role Costume."

Chaperone Code of Conduct

The National High School Musical Theatre Awards® is a national celebration of outstanding student achievement in high school musical theatre. This program recognizes individual artistry in vocal, dance, and acting performance, as well as honors teachers and their schools' commitment to excellence in performing arts education. In keeping with the mission of the organization, Chaperones understand and acknowledge that they must maintain the highest moral and ethical character and at all times show respect and fairness during all Jimmy Awards® programs.

As many colleges and universities are hosting a growing number of programs for high school age students, The Juilliard School, among others, has put in place tools to assist adults supervising the high school students with an understanding of some general policies and rules related to Mandated Reporting of Abuse. All Chaperones will be required to complete a free, online training program to build your understanding of the definition of abuse in this setting and your legal obligation to report it, as well as the pathways to do so. This information will be provided in a separate communication.

A Chaperone's primary responsibility is the welfare of all Nominees during the NHSMTA® week. Each Chaperone will be expected to collaborate throughout the week with a group of Chaperones to oversee a "pod" of Nominees, comprised of the two (2) Nominees from the Chaperone's RAP as well as Nominees from other Regional Awards Programs.

The responsibilities of a Chaperone include:

- Attending Chaperone Information Sessions and advance pod meetings over Zoom, schedule allowing.
- Caring for the health and safety of the Nominee(s) at all times. Chaperones are required to remain fully apprised of all medical needs of the Nominee(s), including prescription medication, special dietary needs, and any ongoing care needed as relates to a known health condition.
- Escorting the Nominee(s) safely to and from rehearsals and official program activities and making sure Nominee(s) are where they are required to be, such as at the proper rehearsal, coaching session, or meal.
- Conducting nightly bed checks and floor checks as directed and remain in the Chaperone's assigned housing after such checks.
- Providing moral support to Nominees during the program and helping manage evening rest (ensuring Nominees are in their rooms and getting rest appropriate to participate fully in program activities).
- Communicating with the Nominees' parent(s) and/or Legal Guardian(s) regularly during the program week.
- Collaborating throughout the week with a group of Chaperones to oversee a "pod" of Nominees, comprised of the two (2) Nominees from the Chaperone's RAP as well as Nominees from other Regional Awards Programs.
- Complying with all instructions and/or directives given by NHSMTA/Jimmy Awards staff, including NHSMTA Chaperones/Pod Leaders.

Chaperones must be at least 21 years of age by the first day of the program in New York City (Friday, June 13, 2025).

There will be a chaperone meeting to review expectations during the Nominees' first rehearsal on Saturday, June 14th. Please note that The Juilliard School has a one-strike policy for Code of Conduct violations.



Reference Form A – RAP Chaperone Approval Form (4 of 5)

Consequences for Code of Conduct violations by RAP Chaperones include:

- Any and all RAP Chaperone incidents will be documented by the NHSMTA and shared with the RAP's Broadway League Member sponsoring organization.
- RAP Chaperones will receive a verbal warning and/or redirection for the first minor infraction.
- RAP Chaperones will be informed they are ineligible to return the following year if there is a second minor infraction.
- A third minor infraction will result in dismissal from the program.
- Any RAP Chaperone who commits an egregious violation of the Code of Conduct (i.e. putting or allowing a student Nominee to be in a potentially unsafe or dangerous situation) will be dismissed from the program immediately.

Chaperones are not responsible for costuming input, artistic input, or program administration. Nor is there access to rehearsal or coaching sessions unless expressly invited by the Jimmy Awards Director, Van Kaplan.

I understand that consequences for Code of Conduct violations may include discipline, up to and including dismissal from the program.
